## Record Documents Electronically

Benton County now offers eRecording, real property related instruments, as a service option to our business partners and constituents.

eRecording provides our customers with the ability to record documents with the Benton County Clerk via the internet, utilizing one of the four approved eRecording service providers.

Instead of submitting records by mail, with eRecording, customers can simply scan the original document, attach the electronic image and appropriate fees for electronic payment, through our eRecording Partners or via one of the four approved service providers. Next, the electronic instrument is transmitted by a secure connection to the County Recorder's office for review. If there are questions or missing elements, the deficiencies can usually be resolved within the same business day. If all required elements are present in the instrument, it is accepted for inclusion in the permanent public records maintained by the department.
