Dear Benton County Voter:

Tuesday, November 8, 2022, is General Election day in Oregon. As a registered voter, you have the opportunity to exercise your right to vote on a variety of federal, state, county, and city contests. The contests and measures that appear on your ballot are dependent on the districts in which you reside. If you live in the City of Philomath and/or the Philomath School District, you will have local measures to consider. Additionally, the City of Corvallis has adopted Ranked Choice Voting for Mayor and City Council contests with three or more filed candidates. This is also an election in which voters will elect a County Commissioner and other public officials who will represent us at the national, state and local levels, as well as, statewide measures.

The County publishes voters' pamphlets to provide local candidates with the opportunity to share their message with voters. This pamphlet also provided measure proponents and opponents with the opportunity to submit arguments in support of or in opposition to local measures. An electronic version of this pamphlet is available on the County Clerk's Elections Division website at www.co.benton.or.us/elections.

Voters have three options for returning their voted ballots. By mail, postmarked no later than Election Day and received by the Elections Office by the seventh day after Election Day. In-person at any Oregon County Elections Office or any Official Ballot Drop Site in the State of Oregon before 8:00 PM on Election Day, Tuesday, November 8, 2022.

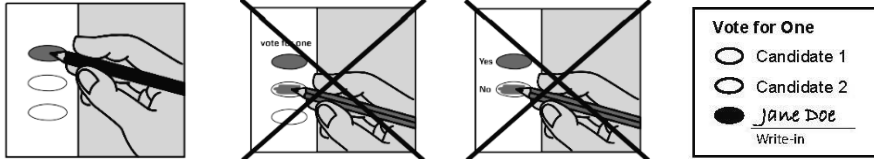
Voting Instructions

Your Ballot Packet Contains

- A printed ballot on which you may vote
- A prepaid and pre-addressed signature return envelope in which to return your ballot

Voting Your Ballot

- Use a black or blue pen to fill in the ovals next to your choices.
- You do not have to vote on all contests. Those contests you do vote on will still count.
- If you vote for more candidates than allowed or if you vote both Yes and No on a measure, it is called an overvote and your vote will not count for that candidate or measure.
- To write-in a candidate who does not appear on your ballot, completely darken the oval to the left of the write-in line and write the full name of the candidate on that line.



Correcting Your Ballot

If you make an error on your ballot, you may correct it yourself. See examples below:

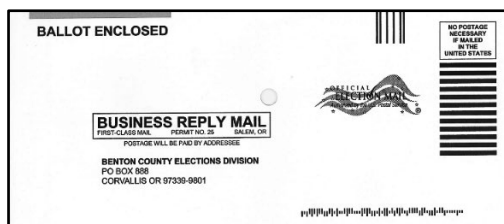
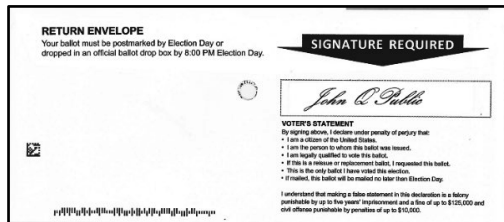


Contact Benton County Elections to request a replacement ballot if:

- You are unable to correct a mistake to make your intended choice clear
- Your ballot is damaged or spoiled
- You lose your ballot

Returning Your Voted Ballot

- **SIGN** the voters' statement on the back of the signature return envelope. Your ballot will not be counted if your return envelope is not signed.
- Insert ballot into the signed return envelope.
- Seal the signed return envelope.
- **Mail no later than November 8, 2022.** It must be postmarked by Election Day and received no later than seven days after Election Day.
- Or place the signed return envelope in an **Oregon Official Ballot Drop Box by 8:00 PM PST November 8, 2022.**

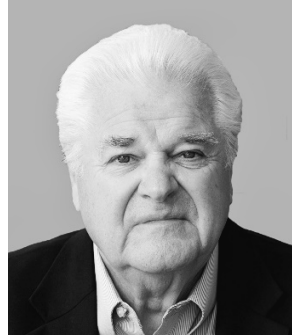

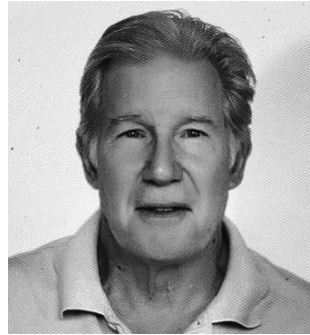

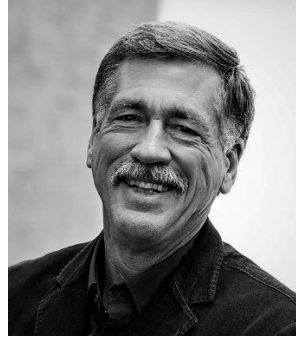

The City of Corvallis has adopted the ranked choice voting method in elections for Mayor and City Council and for advisory questions.

What is it? Ranked choice voting is a method that gives voters the ability to rank candidates in order of preference – 1st choice, 2nd choice, and 3rd choice.

When does it apply? In the 2022 Corvallis municipal general election, ranked choice voting will apply for the races with three or more candidates. Voters will use ranked choice voting for the Corvallis Mayor and Ward 9 City Councilor races. For all other Corvallis City races, voters will select one candidate.

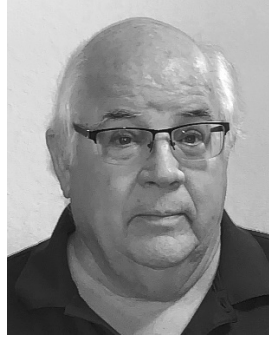

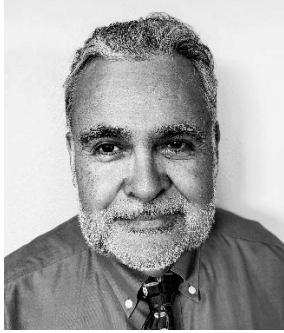

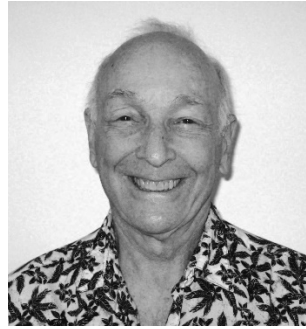

City of Philomath Measure 2-138

Ballot Title

Caption: Moratorium on psilocybin manufacturing and service facilities in Philomath

Question: Should Philomath place a two-year moratorium on facilities that manufacture or administer Psilocybin product within City limits?

Summary: State law allows for the operation of licensed Psilocybin service centers and manufacturing facilities. State law provides that a city council may adopt an ordinance to be referred to the voters to prohibit the establishment of any of those registered or licensed facilities within the area subject to the jurisdiction of the city for a two-year period.

Approval of this measure would prohibit the establishment of facilities that manufacture Psilocybin product or service centers that supervise Psilocybin administration and delivery to clients of the service centers within area subject to the jurisdiction of the City of Philomath until after December 31, 2024.

Regardless of whether this measure passes or fails, Measure 109 prohibits the City from imposing a local tax or fee on the manufacturing or sale of psilocybin products.

Approval of this measure would prohibit the establishment of certain Psilocybin activities within the City of Philomath until after December 31, 2024.

Explanatory Statement

Oregon Ballot Measure 109, approved Nov. 3, 2020, effective Dec. 3, 2020, (codified as ORS 475A) created a state program for administering psilocybin products, such as psilocybin-producing mushrooms and fungi, to individuals aged 21 years or older. Measure 109 also provides that the Oregon Health Authority will register and license Psilocybin manufacturing sites, Psilocybin service centers, and entities that are any combination of the two. Psilocybin product manufacturers grow, harvest, and manufacture Psilocybin fungi into products intended for human consumption and use. Psilocybin service centers facilitate the transfer and administration of Psilocybin between a licensee or licensee agent and the client of the service center.

Measure 109 allowed cities and counties to place referendums on local ballots to place a two-year moratorium on the ability of licensed psilocybin product manufacturers or licensed psilocybin service centers to be located or to operate in areas within their jurisdictions. Approval of this measure will prohibit any form of psilocybin service centers or manufacturer facilities within the limits of Philomath for two years. During this time, the City Council has the discretion to adopt time, place, and manner restrictions on psilocybin manufacturing entities and service centers. At the end of the moratorium, the City Council can decide to submit the question of a permanent ban to the voters, or it can allow Measure 109 to take effect within the city limits.

Approval of this measure may have revenue impacts. Currently, a state tax of fifteen percent will be added to all transactions relating to Psilocybin, but no distribution schedule to local entities has been created by the Department of Revenue. The state prohibits all cities and counties from imposing any additional taxes on the sale of Psilocybin items by a Psilocybin product manufacturer or service center in the area subject to the jurisdiction of the city or county.

City of Philomath Measure 2-138 Argument in Favor

YES on Measure 2-138

A YES vote will stop, for two years, facilities that manufacture or administer Psilocybin products in Philomath.

Psilocybin = Psychedelic Mushroom-Hallucinogenic

The US Government has categorized Psilocybin as a Schedule 1 drug; having a high potential for abuse and no currently accepted medical use in the United States. Oregon's passage of Measure 109 in 2020 allows the operation of Psilocybin service centers and manufacturing facilities, in violation of Federal Law.

Psilocybin may be a useful mental health medical treatment option; **Oregon has chosen to go the non-medical route to dispense Psilocybin.** The Oregon Health Authority (OHA) will license and regulate the manufacturing, transportation, delivery, sale and purchase of Psilocybin products and the provision of Psilocybin services. The first subset of rules OHA adopted provide that a licensed facilitator need only be 21 years of age with 120 hours of training to be eligible to administer this Schedule 1 drug. Other than a high school degree, no additional degrees or certifications are required. (NO MEDICAL DEGREE – only a high school diploma.) **There is no medical component in the rules/regulations governing Psilocybin.**

OHA has until 12/31/2022 to finalize all Psilocybin regulations. **Until we know the actual rules and regulations, we cannot make an educated choice.** WHEN we have the facts, we can decide whether or not to support the manufacturing and sale of Psilocybin in our community. Anything else is irresponsible.

A YES vote gives us two years to evaluate Psilocybin services.

A NO vote brings Psilocybin to the City of Philomath as early as January 2023.

Ballot Title

Caption: Renewal of five-year local operating levy for K-12 education

Question: Shall district renew K-12 operating levy of \$1.50 per \$1,000 of assessed value for five years beginning 2023-2024? This measure renews current local option taxes.

Summary: This measure would continue the local option levy approved by voters in 2013 and renewed in 2018. If renewed, the current levy rate would not increase from the originally approved 2013 rate.

The Philomath School District will use revenue to enact its vision "to graduate every student and transition each into a job, training, or college" by prioritizing small class sizes, full school days, instructional time, and programs such as performing and visual arts, forestry and manufacturing technology, foreign languages, advanced courses, athletics and activities, and the community pool. The district's four-year cohort graduation rate is currently 90%.

Since passing the current levy, the district has maintained all licensed staff, current program offerings, and all school days, despite decreased enrollment. If funding is not renewed, the district would need to make staffing and program cuts.

The proposed levy will raise approximately \$1.12 million in 2023-2024, \$1.15 million in 2024-2025, \$1.19 million in 2025-2026, \$1.23 million in 2026-2027, and \$1.26 million in 2027-2028 for a total of \$5.95 million.

Explanatory Statement

The Philomath School District (PSD) provides education, activities, and athletics services to roughly 1,600 students throughout western Benton County, including the communities of Philomath, Blodgett, Wren, and Kings Valley.

The district is seeking to renew the current operating levy of \$1.50 per \$1,000 of assessed value for five years, beginning in 2023-2024. Renewal would keep taxes at the same rate originally approved in 2013. Voters in the district originally approved this levy in 2013 to fund robust staffing levels and program offerings for students, and renewed it in 2018 to continue providing these services. In the time since passage, the revenue from the levy has allowed the Philomath School District to maintain staffing levels and provide a wide array of athletic, arts, science, career readiness, training, and citizenship programs in addition to core academic subjects.

Without continued funding from the local operating levy, the Philomath School District would likely need to cut school days, school hours, teaching staff, classified staff, and/or vocational programs, arts, sports, or other co-curricular activities. Approving this renewal would not raise tax rates.

The Philomath School District uses levy funds to provide a holistic and engaging academic and extracurricular program to students from kindergarten to high school graduation. This includes daily music or PE programs that benefit all elementary-level students, a weeklong outdoor school program for all 6th graders, and middle school band and choir programs that see high engagement levels. At Philomath High School (PHS), students have the opportunity to participate in strong, award-winning forestry, manufacturing technology, culinary arts, health occupations, and other career-readiness classes that prepare students for life after graduation.

Philomath High School's academic programs, athletic teams, and performing arts programs consistently perform at high levels, with graduation rates at 90% and recent state championships in Girls Basketball (2022), Girls Track and Field (2022), Boys Soccer (2021) and Band (2019). In addition, PHS won the 2021-2022 Oregon School Activities Association (OSAA) Cup, which "recognizes overall school excellence in academics, activities, athletics and sportsmanship."

The Philomath School District finances and manages the Clemens Community Pool and many athletic fields and facilities which are available for use by the public as well as students.

As part of the Philomath School District, Kings Valley Charter School (KVCS) provides a rural, community-based education tailored to the individual needs and interests of each child, emphasizing the involvement of parents and the community. KVCS educates nearly 200 students from kindergarten through high school.

Unlike one-time grants, the local option levy provides consistent operating funds which can be spent on staff and faculty salaries and ongoing core expenses. 100% of revenue raised by the local option levy stays under local control, overseen by the district's citizen budget committee and/or the KVCS board.
