#### **VOTER REGISTRATION**

You may register to vote by mail or in person if:

- (1) You are a citizen of the United States;
- (2) You will be 18 years of age or older on election day; and
- (3) You are a resident of Oregon.

**IMPORTANT:** You may register to vote if you meet the above qualifications, but must be registered by 5:00 p.m. on March 2, 1993.

However, if you have moved or your name has changed and you have not yet reregistered, you may still be able to do so. Contact the Benton County Office of Elections at 757-6756 for further information.

You must reregister if:

- (1) Your registration has been canceled;
- (2) Your name has been changed by marriage or court order;
- (3) Your residence or mailing address has changed for any reason; or
- (4) You desire to change your political party affiliation.

You may vote one time in the precinct of registration without reregistering if:

- (1) Your name has been changed by marriage or court order;
- (2) Your residence or mailing address has been changed by the United States Postal Service, or city or county, but the location of the residence has not changed and you qualify for and obtain a certificate of registration from the county election office; or
- (3) Your mailing address has changed but the location of your residence has not changed.

You may cast a ballot even though there may be a question about the validity of your registration.

If such a question exists, the election official may require you to vote a "challenged" ballot. You will be required to sign a statement indicating you believe you are eligible to vote the ballot being issued.

The "challenge" process is provided by Oregon law and simply means your ballot will not be counted until the election official can determine you were entitled to vote. The election official has until the 19th day after the election to determine the validity of your registration. This process is used to assure no voter is denied the constitutional right to vote because of an administrative error and to make certain votes which may be fraudulent are not counted.

## STATE OF OREGON **VOTER REGISTRATION INSTRUCTIONS**

A qualified person must complete this form, sign the certification and mail or deliver to any county elections office or the Secretary of State's office. The date of registration is the date on which the legible, accurate and complete registration card is received. To be eligible to vote, you must register by 5 p.m. on the 21st day before the election at which you intend to vote.

#### YOU MAY REGISTER TO VOTE IF:

- 1. You are a citizen of the United States
- 2. You will be 18 or older on election day and
- 3. You are a resident of Oregon.

#### YOU MUST RE-REGISTER IF:

- 1. Your residence or mailing address changes
- 2. Your name changes or
- 3. You wish to change political affiliation.

If you have any questions on registration or re-registration, contact your county elections office.

## ABSENT VOTER

You may apply for an absentee ballot from your county clerk if:

- 1. You are a registered voter, and
- You have reason to believe you will be unable, for any reason, to vote at the polling place on election day.

#### Your application must be in writing and must include:

- Your signature. (This is required, for comparison to your voter registration card.)
- Your residence address.
- The address to which the ballot should be mailed, if different from your residence.

YOUR VOTED BALLOT MUST BE RECEIVED IN THE OFFICE OF YOUR COUNTY CLERK NOT LATER THAN 8:00 P.M. THE DAY OF THE ELECTION, MARCH 23, 1993.

If a registered voter is physically disabled, the application is valid for every election held during the calendar year for which the application is received.

While you may apply for and receive an absentee ballot up to 8:00 p.m. on election day, if your application is received by the county clerk after 5th day prior to the election, the county clerk is not required to mail your ballot. If your ballot is not mailed, you must obtain it in person from the county clerk. Therefore, if you apply for an absentee ballot by mail, you must allow enough time to receive the ballot, vote, and return the ballot to the county clerk. **REMEMBER:** Your voted ballot must be physically in the office of the county clerk by 8:00 p.m. on the day of the election, March 23, 1993, or it will not be counted.

## LONG TERM ABSENT VOTER

You may apply for long term absent voter status with your county clerk or the Secretary of State if:

- You are a resident of this state, absent from your place of residence, and
- You are serving in the armed forces or merchant marine of the United States, or
- 3. You are temporarily living outside the territorial limits of the U.S. and the District of Columbia, or
- 4. You are a spouse or dependent of a long term absent voter. A spouse or dependent of a long term absent voter, not previously a resident of this state who intends to reside in this state, is considered a resident for voting purposes and may vote in the same manner as a long term absent | X voter.

#### Your application must be in writing and must include:

- 1. Your name and current mailing address.
- 2. A statement that you are a citizen of the U.S.
- 3. A statement that you will be 18 or older on the day of the election.
- 4. A statement that your home residence has been in this state for more than 20 days preceding the election, and giving the address of your last home residence.
- A statement of the facts that qualify you as a long term absent voter.
- A statement that you are not requesting a ballot from any CITY
  other state and are not voting in any other manner than |
  by absentee ballot.
- 7. A designation of your political affiliation if you wish to vote in a primary election.

  MAIL THIS APPLICATION TO THE COUNTY CLERK OF THE

The U.S. Department of Defense provides standard form 76 that complies with these requirements. It is recommended that long term absent voters use this form—available at embassies and military installations—whenever possible.

Your long term absentee ballot application will be valid for all elections held in the calendar year for which it is received.

Special absentee voting instructions and a ballot return envelope will accompany each absentee ballot.

Special Absentee Ballots: Any long term absentee voter may obtain a special absentee ballot for a primary or general election if the voter believes that:

- The voter will be residing, stationed or working outside the territorial limits of the United States and the District of Columbia; and
- The voter will not be able to receive, vote and return a regular absentee ballot by normal mail delivery within the period provided for absentee voting.

If you feel you may need a special absentee ballot, you should contact your county election officer for details.

REMEMBER, YOUR BALLOT MUST BE RECEIVED BY YOUR COUNTY CLERK NO LATER THAN 8:00 P.M. THE DAY OF THE ELECTION, MARCH 23, 1993.



#### TO VOTE:



#### QUESTION:

Shall the District issue bonds in an amount of \$5,000,000 to acquire, improve, and equip school facilities? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of Section 11b, Article XI of the Oregon Constitution.

#### **EXPLANATION:**

Bond proceeds shall be expended to acquire, construct, reconstruct, improve, repair, equip, and furnish school buildings, and additions thereto; to improve school sites and to provide certain handicap accessibility. The Bonds will mature over a period not to exceed twenty (20) years.

The Philomath school district is asking voters to approve a \$5 million levy to provide school facilities needed to meet the needs of a growing enrollment. Since the last bond levy was passed in 1972 the number of students has grown by over 450 students, enough to fill a new school. The last three years has seen the enrollment grow by over 225 students.

Philomath schools are overcrowded to the extent that classes are being held in a local church, on stage at the high school, in recently purchased modulars and in library space that has been walled in for extra classrooms. The high school science laboratory space and media center are inadequate in size and are outdated.

#### WHAT WILL THE BOND LEVY PROVIDE?

- 1 Badly needed classroom space in our schools.
- 2 Adequate high school science labs.
- 3 New high school library/media center.
- 4 Support space a the Philomath Elementary School including:
  - a a new gym
  - b multi-purpose room

For years, the Philomath School Board has operated under a fiscal policy that put facilities last in the budgeting process. Maintenance and construction of facilities had to wait until all other budget items were covered. The results are a severe classroom shortage, facilities in poor repair, and for the second time in less than two years the taxpayers are being asked to approve a bond levy to make up for past mis-handling of funds.

The immediate response of the board to the defeat of the November 1991 bond levy proposal was to begin making plans for the next attempt. The board spoke of the need to "educate the public and to determine how large a proposal might be approved. One board member suggested that the next attempt should be made during the rainy season, and that the G-T should be called in for a "media event."

During the ensuing fourteen months, at least two workable plans to solve the problem without a levy have been presented to and ignored by the board. Both these ideas involve budgeting for facilities first. The only real impediment to implementing either of these plans is the lack of will on the part of the board to defy the OEA.

For more than ten years, the Oregon Legislature refused to hear the taxpayers' plea to cut spending. The result was Measure 5. To paraphrase Don McIntire, co-sponsor of Measure 5, "Philomath does not have a revenue problem. Philomath has a spending problem."

# CHARTER AMENDMENT FILLING MAYORAL VACANCY BY ELECTION RATHER THAN APPOINTMENT

#### QUESTION:

Shall Charter provision requiring appointment to fill vacant elective offices be amended to provide one-time election to fill Mayoral vacancy.

#### **SUMMARY:**

In May 1992 the citizens passed an initiative petition amending the City Charter to change the selection of Mayor from an appointive to an elective office. In the November 1992 general election no Mayor was elected and a vacancy occurred. This measure will amend Article VII, §32 of the Charter which now requires vacant elective City offices to be filled by appointment in order to effectuate the intent of the initiative petition.
