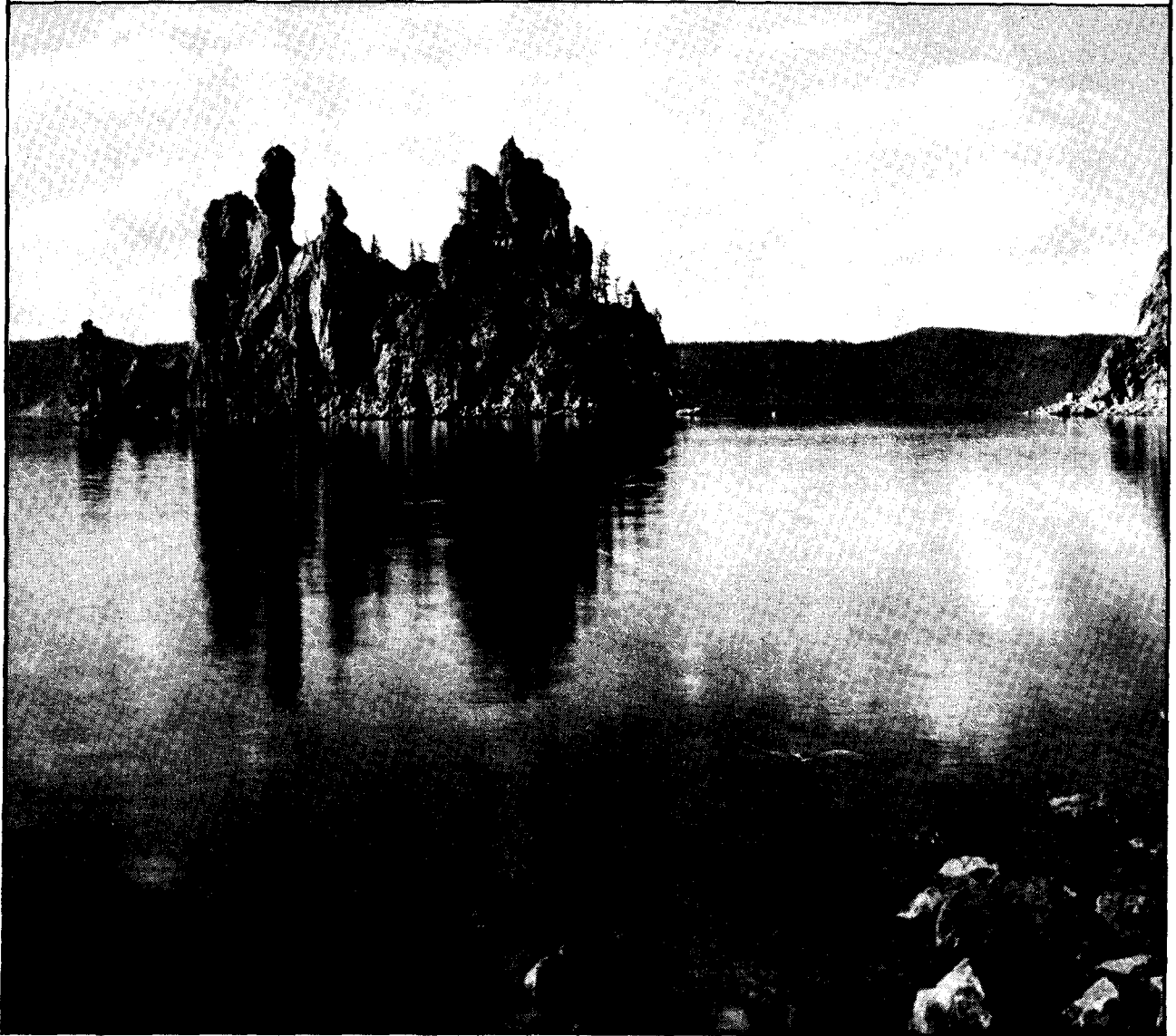

Dear Voter:


We encourage you to carefully review the 1994 Primary Election Voters' Pamphlet to assist you in making important choices that affect your future. In addition to important information about candidates and Ballot Measure 2 — the one issue referred by the 1993 Legislature for the Primary Election ballot — this Voters' Pamphlet contains information about absentee ballots, accessibility of polling places for elderly and physically disabled voters, and voter registration.

New laws enacted by the 1993 Legislature made some changes to Oregon's election laws and the Voters' Pamphlet. These include:

- (1) Elimination of pages that were previously used to divide sections (Measures, Republican Candidates, Democratic Candidates, Nonpartisan Candidates). This change results in significant cost savings. Partisan candidates continue to be printed in separate sections. This year all Republican candidates will be in the first section of candidates, all Democratic candidates will be in the second section, and all nonpartisan candidates are in the third section. Please refer to the table of contents for the specific page numbers.
- (2) Numbers for state and local ballot measures will not be repeated until the number "99" is reached, rather than starting with the number "1" for each election. This change is intended to reduce the confusion in distinguishing different ballot measures from previous elections. The new system began with Ballot Measure 1 for the November 9, 1993, Special Election on the sales tax.
- (3) While the Voters' Pamphlet continues to list the names of candidates for each office in alphabetical order, candidate names will appear on the ballot in an order generated by a random selection of the alphabet. This change saves tax dollars because it replaces the previous practice of "rotating" names, which required the printing of many different ballots.
- (4) To save state tax dollars, certain local candidates and measures are no longer automatically included in your state Voters' Pamphlet. However, your county has chosen to furnish the information and print this pamphlet jointly with the state, thereby reducing duplicate costs for binding and mailing. Your county's Voters' Pamphlet is inserted in the center, indicated clearly with a color bar on the outside edge.
- (5) Candidate statements for different elective offices may appear on the same Voters' Pamphlet page. These statements are separated by two vertical lines in the center of the page. This change eliminates blank columns and saves tax dollars by reducing paper and printing costs.

Remember, you must be registered by 5:00 p.m. on April 26, 1994, to vote in the Primary Election. Please be sure to cast your vote on Tuesday, May 17 — your fellow Oregonians are counting on it.

INFORMATION

GENERAL

Your official 1994 Primary Election Voters' Pamphlet is divided into separate sections for measures and candidates. You can find page numbers for the beginning of each of these sections, as well as for the alphabetical index of candidates, in the table of contents on this page.

Material in the measures section includes each state ballot title, estimate of financial impact, the complete text of the proposed measure, an impartial statement explaining the measure and any arguments filed by proponents and opponents of the measure.

Oregon law allows the Legislature to submit one argument in support of each measure it refers to the people. Citizens or organizations may also file arguments in favor of or in opposition to measures by purchasing space for \$500 or by submitting a petition signed by 2,500 voters. The Secretary of State may not accept any argument which is not accompanied by the specified fee or the requisite number of signatures.

In the candidate section, partisan candidates appear before nonpartisan candidates. All space is purchased; statements and photographs are submitted by the candidates or their designated agents. The information required by law—pertaining to occupation, occupational background, educational background and prior governmental experience—has been certified by each candidate.

Miscellaneous voting aids, including district maps, precinct and polling place lists, voting instructions, a complete list of state candidates, and absentee ballot applications, are also a part of the Voters' Pamphlet. Another page, "Voting Accessibility for Elderly and Individuals with Physical Disabilities," contains information about provisions made for elderly or physically disabled voters.

The Voters' Pamphlet has been compiled by the Secretary of State since 1903, when Oregon became one of the first states to provide for the printing and distribution of such a publication. In 1909, the Legislature passed a law requiring pamphlets to include information on candidates.

One copy of the Voters' Pamphlet is mailed to every household in the state. Additional copies are available at the State Capitol, local post offices, courthouses and all county election offices.

VOTER REGISTRATION

You may register to vote by mail or in person if:

1. You are a citizen of the United States;
2. You will be 18 years of age or older on election day; and
3. You are a resident of Oregon.

IMPORTANT: You may register to vote if you meet the above qualifications, but you must be registered by 5:00 p.m. on April 26, 1994.

You must reregister if:

1. Your registration has been canceled;
2. Your name has been changed by marriage or court order;
3. Your residence or mailing address has changed for any reason; or
4. You desire to change your political party affiliation.

You may vote one time in the precinct of registration without reregistering if:

1. Your name has been changed by marriage or court order;
2. Your residence or mailing address has been changed by the United States Postal Service, or city or county, but the location of the residence has not changed and you qualify for and obtain a certificate of registration from the county election office; or
3. Your mailing address has changed but the location of your residence has not changed.

You may cast a ballot even though there may be a question about the validity of your registration.

If such a question exists, the election official may require you to vote a "challenged" ballot. You will be required to sign a statement indicating you believe you are eligible to vote the ballot being issued.

The "challenge" process is provided by Oregon law and simply means your ballot will not be counted until the election official can determine whether you were entitled to vote. The election official has until the 19th day after the election to determine the validity of your registration. This process is used to assure no voter is denied the constitutional right to vote because of an administrative error and to assure that votes which may be fraudulent are not counted.

YOU MUST BE REGISTERED TO VOTE BY 5:00 P.M. ON APRIL 26, 1994.

HOUSE JOINT RESOLUTION 69—Referred to the Electorate of Oregon by the 1993 Legislature, to be voted on at the Primary Election, May 17, 1994.

PARAGRAPH 2. The amendment proposed by this resolution shall be submitted to the people for their approval or rejection at a special election held throughout this state on the same date as the next regular primary election.

BALLOT TITLE

2 CAPTION: ALLOWS NEW MOTOR VEHICLE FUEL REVENUES FOR DEDICATED PURPOSES

QUESTION: Shall Constitution allow new fees on wholesale importation of motor vehicle fuels for programs to: preserve fuel availability, remedy and prevent petroleum product environmental contamination?

EXPLANATION: Amends Oregon Constitution. The Constitution now limits use of motor vehicle fuel taxes to construction and maintenance of public roads and roadside rest areas. This change would allow the legislature to dedicate future fees on wholesale importation of motor vehicle fuel to programs to preserve fuel availability and to remedy or prevent environmental contamination caused by storage, use or distribution of motor vehicle fuel or petroleum products. The change would not apply to fuel taxes now collected.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

Be It Resolved by the Legislative Assembly of the State of Oregon:

PARAGRAPH 1. Section 3a, Article IX of the Constitution of the State of Oregon, is amended to read:

Sec. 3a. (1) Except as provided in [subsection (2)] subsections (2) and (3) of this section, revenue from the following shall be used exclusively for the construction, reconstruction, improvement, repair, maintenance, operation and use of public highways, roads, streets and roadside rest areas in this state:

(a) Any tax levied on, with respect to, or measured by the storage, withdrawal, use, sale, distribution, importation or receipt of motor vehicle fuel or any other product used for the propulsion of motor vehicles; and

(b) Any tax or excise levied on the ownership, operation or use of motor vehicles.

(2) Revenues described in subsection (1) of this section:

(a) May also be used for the cost of administration and any refunds or credits authorized by law.

(b) May also be used for the retirement of bonds for which such revenues have been pledged.

(c) If from levies under paragraph (b) of subsection (1) of this section on campers, mobile homes, motor homes, travel trailers, snowmobiles, or like vehicles, may also be used for the acquisition, development, maintenance or care of parks or recreation areas.

(d) If from levies under paragraph (b) of subsection (1) of this section on vehicles used or held out for use for commercial purposes, may also be used for enforcement of commercial vehicle weight, size, load, conformation and equipment regulation.

(3) Revenues from a tax levied on, with respect to, or measured by the wholesale importation of motor vehicle fuel may also be used for programs to preserve motor vehicle fuel availability and to remedy and prevent environmental contamination caused by the storage, use or distribution of petroleum products, but only if the revenue results from such a tax that is levied on or after January 1, 1994, and that is specially dedicated to such programs.

NOTE: Boldfaced type indicates new language; [brackets and italic] type indicates deletions or comments.

EXPLANATORY STATEMENT

The Oregon Constitution restricts uses of revenues from motor vehicle fuel taxes. Such revenues may be used only for highway construction, reconstruction, improvement, repair, maintenance, operation and use, and roadside rest areas.

This measure would amend section 3a, Article IX of the State Constitution to allow revenue from taxes on wholesale importation of motor vehicle fuel to be used for programs to preserve motor vehicle fuel availability and to clean up and prevent environmental contamination caused by the storage, use or distribution of petroleum products, including but not limited to motor vehicle fuel.

This use would be allowed only if the revenue results from a tax levied on or after January 1, 1994, that is specifically dedicated to these purposes. The measure itself imposes no additional taxes, but it authorizes these new uses of revenue. New taxes under this provision could be approved by the Legislature or the people.

LEGISLATIVE ARGUMENT IN SUPPORT

Passage of this measure will contribute to the health of Oregon citizens as well as the health of our economy. Contamination of our soil and water by petroleum products—leaking petroleum storage tanks, accidental spills along our highways and on our coast—must be cleaned up.

Small rural service stations in Oregon are going out of business because they cannot afford to replace old or leaking underground storage tanks. Passage of this measure would allow grants or loans to those small stations that serve our rural population. Some 1500 stations are in danger of being closed. Often these are the only stations in a community.

It makes sense to use some portion of our gasoline tax dollars to remedy this problem, and to preserve the availability of motor vehicle fuel.

ARGUMENT IN FAVOR

ATTENTION EASTERN AND RURAL OREGON

Oregon is facing a potential crisis. The U.S. Environmental Protection Agency has estimated that up to 50% of the stations in rural and Eastern Oregon will close without passage of Ballot Measure 2.

- FACT** Closure of gas stations due to federal regulations of underground tanks threatens to isolate areas of rural and Eastern Oregon.
- FACT** Continued loss of gas stations will cripple small towns and rural economies.
- FACT** Tourism is increasingly important to rural and Eastern Oregon. Without gas stations, this important area of economic development will be lost.

As a petroleum marketer and service station owner, I know first-hand what damage Federal regulations have done to the small gas dealer. The cost of replacing underground tanks can easily exceed \$200,000 per station.

ARGUMENT IN FAVOR

WHY OREGON NEEDS BALLOT MEASURE 2

THE ISSUE

The Federal Government passed a law in the 1980's requiring all service stations to upgrade or replace their underground storage tanks. This means service station owners not only have to buy new tanks and equipment, but they must also pay to remove petroleum from the surrounding soil. Tank replacement and upgrade costs range from \$70,000 to \$200,000 per station. The staggering cost of this environmental remediation threatens to force many independent gasoline dealers out of business.

THE SOLUTION

The Oregon Legislature has approved a program to help gasoline dealers meet the federal requirements and avoid closing stations. A "YES" vote of Ballot Measure 2 will change Oregon's Constitution so that a portion of any new fees levied on petroleum can be used to help independent gasoline dealers survive. Without these changes there will be a dramatic increase in station closures.

The Environmental Protection Agency estimates that up to 50% of the gas stations in rural Oregon will face closure without Ballot Measure 2. The language in Ballot Measure 2 will allow funding for the gas station underground tank program and it will also help fund clean up of abandoned or orphan property in order to protect public health and safety. The Legislature and sponsors of Ballot Measure 2 stated on the record that these two programs, underground tanks and abandoned properties, are the only programs intended for funding.

On May 17, please remember the following issues:

- Ballot Measure 2 will halt the closure of up to 50% of rural Oregon stations. These epidemic closures threaten local economies and obstruct Oregon's overall economic development.
- Oregon tourism will be effected if outlying areas lack convenient access to gas.
- Increased station closures may force many Oregonians to drive 25, 50 or even 75 miles to fuel their vehicle.

ARGUMENT IN OPPOSITION

KEEP OUR TRUST INTACT!

Once again, an attempt is being made to dip into our Highway Trust Fund. Several times in recent years, attempts have been made to grab some of the money dedicated solely for repair, construction and maintenance of our roads.

The State Constitution says "NO!" to using gas tax money for anything other than roads. Voters have repeatedly said "NO" in the past to changing the Constitution. They now need to say "NO!" to Measure 2.

Under the Trust Fund, highway users pay for the construction and repair of our roads and bridges. That's a fair system and it works...the more you use the roads the more you pay.

However, Measure 2 would increase highway users' taxes and make them pay for projects that have nothing to do with roads. Meanwhile, fewer dollars would go to road work.

Oregon already does not have enough money in the state Trust Fund to pay for all of the road projects that are needed right now. Currently, ODOT is cutting about \$400 million from its highway budget because of a shortfall in state and federal gas tax revenues.

As the former Director, a 40-year veteran of the Oregon Department of Transportation and a lifelong Oregonian, I know how essential road maintenance and repair is, especially for motorists' safety.

The fact is, every dollar we collect in gas tax revenues is desperately needed for our roads.

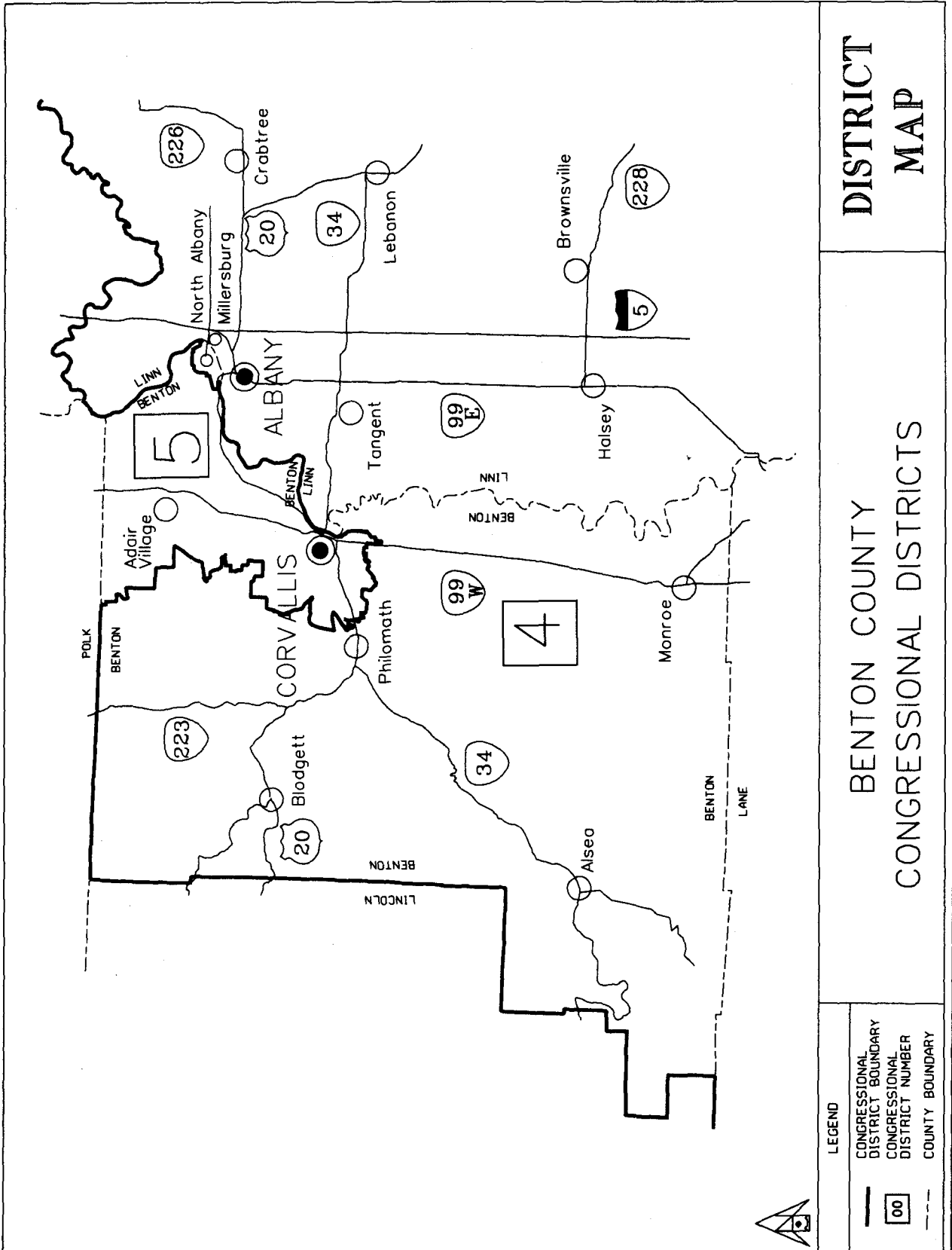

DISTRICT MAP

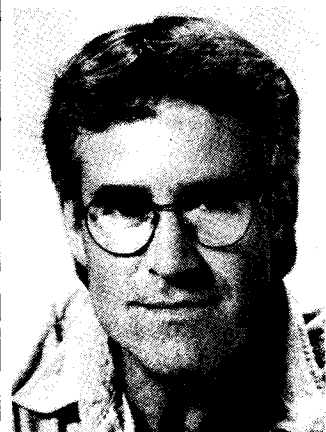
BENTON COUNTY CONGRESSIONAL DISTRICTS

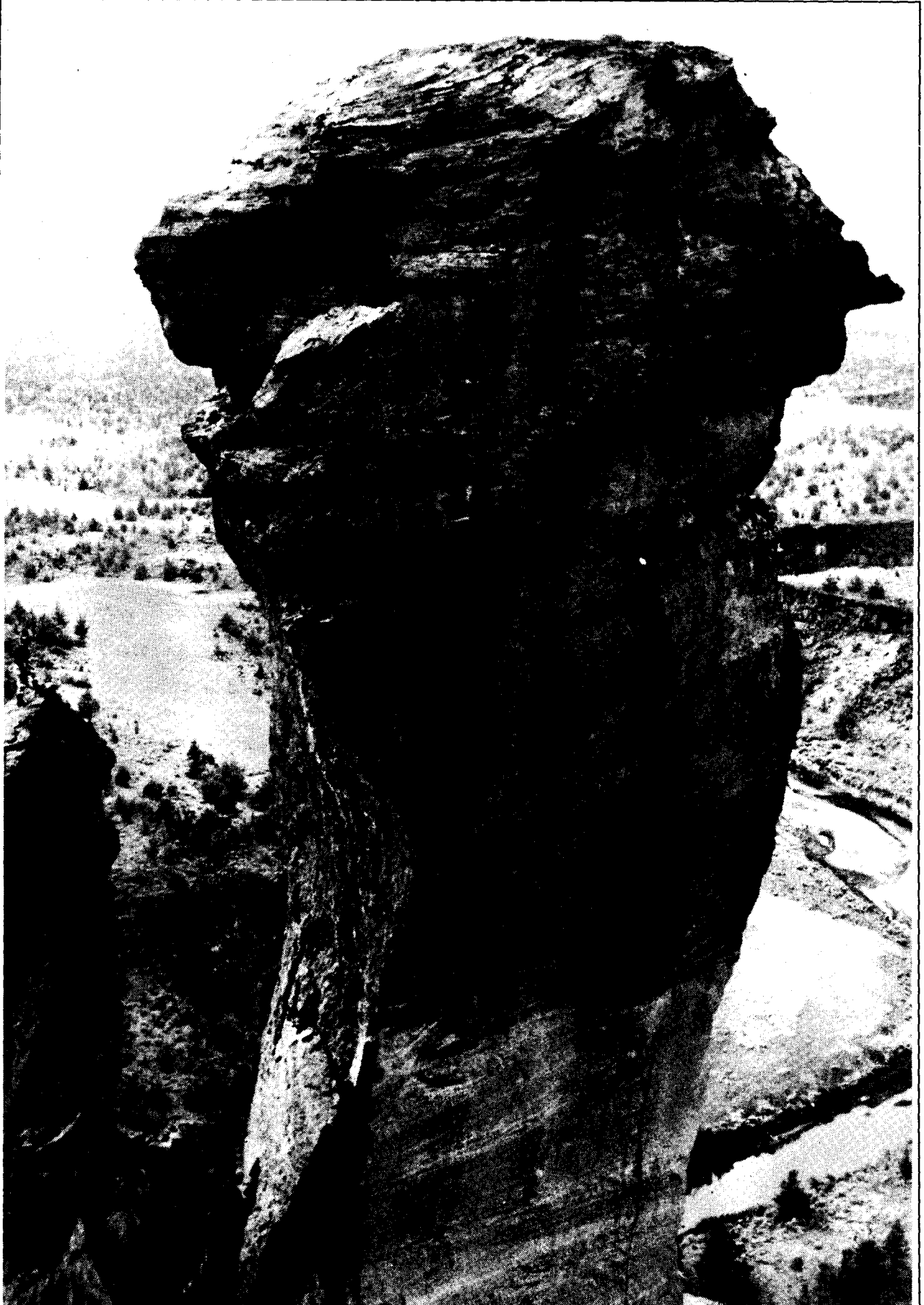

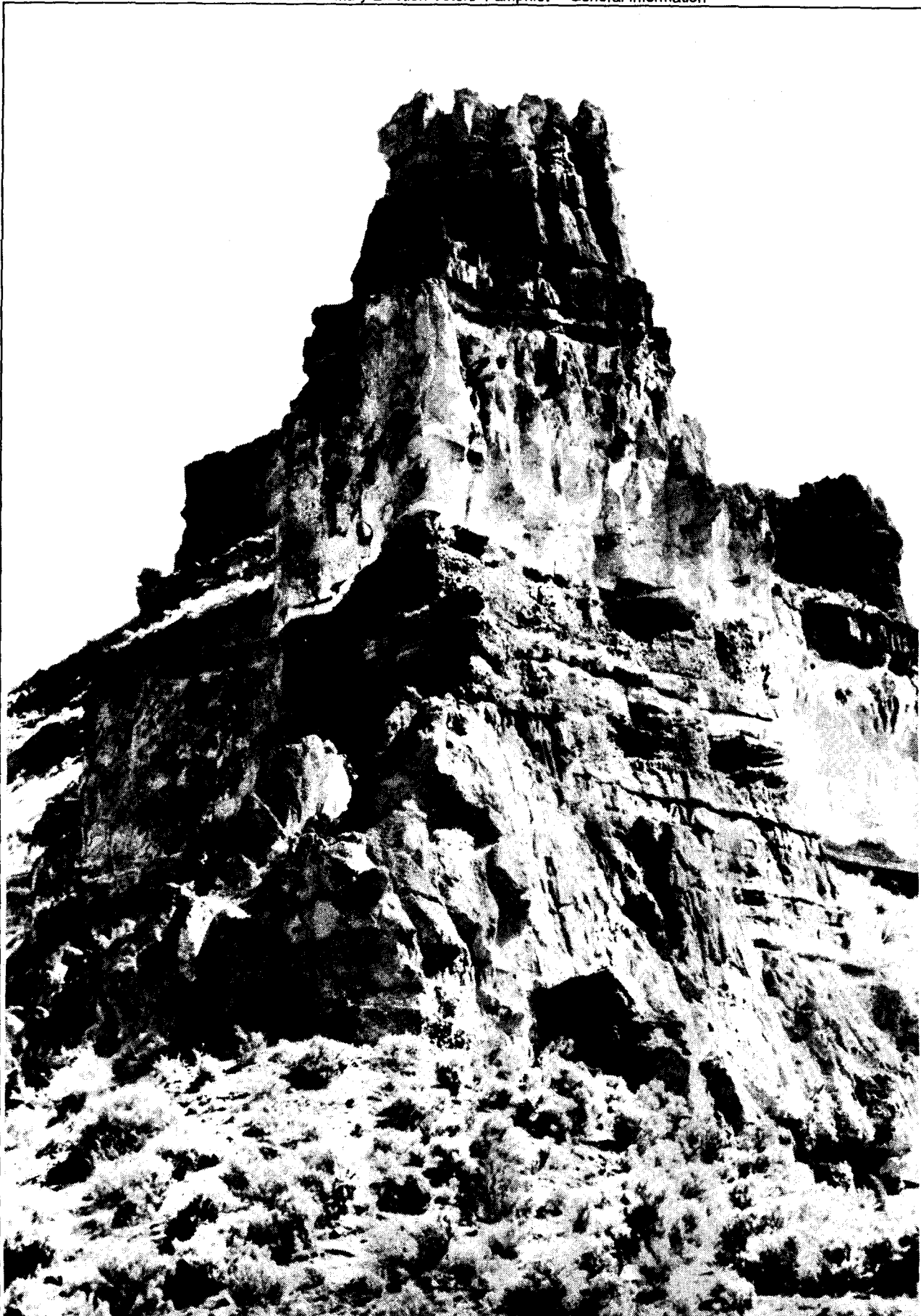

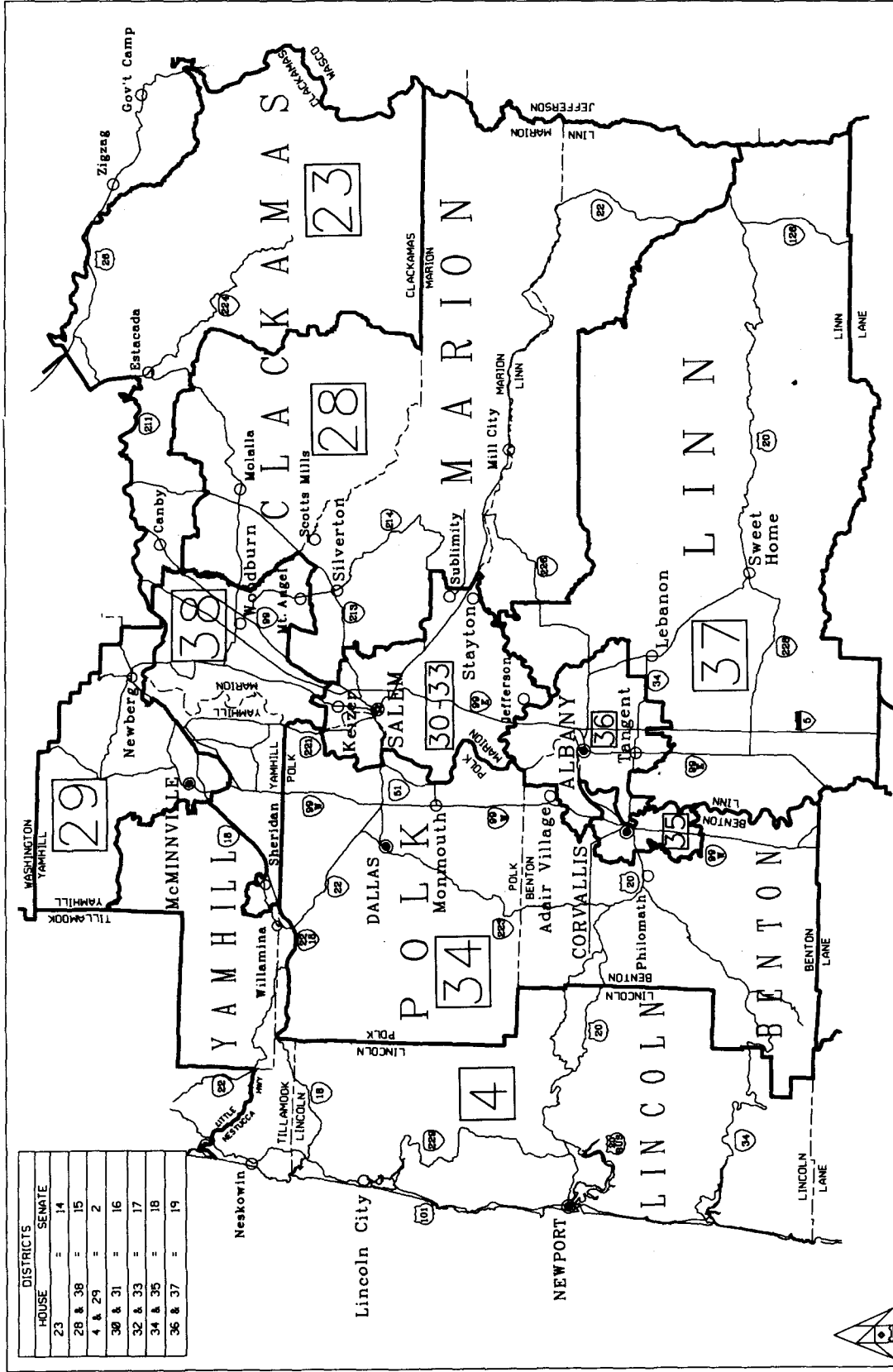

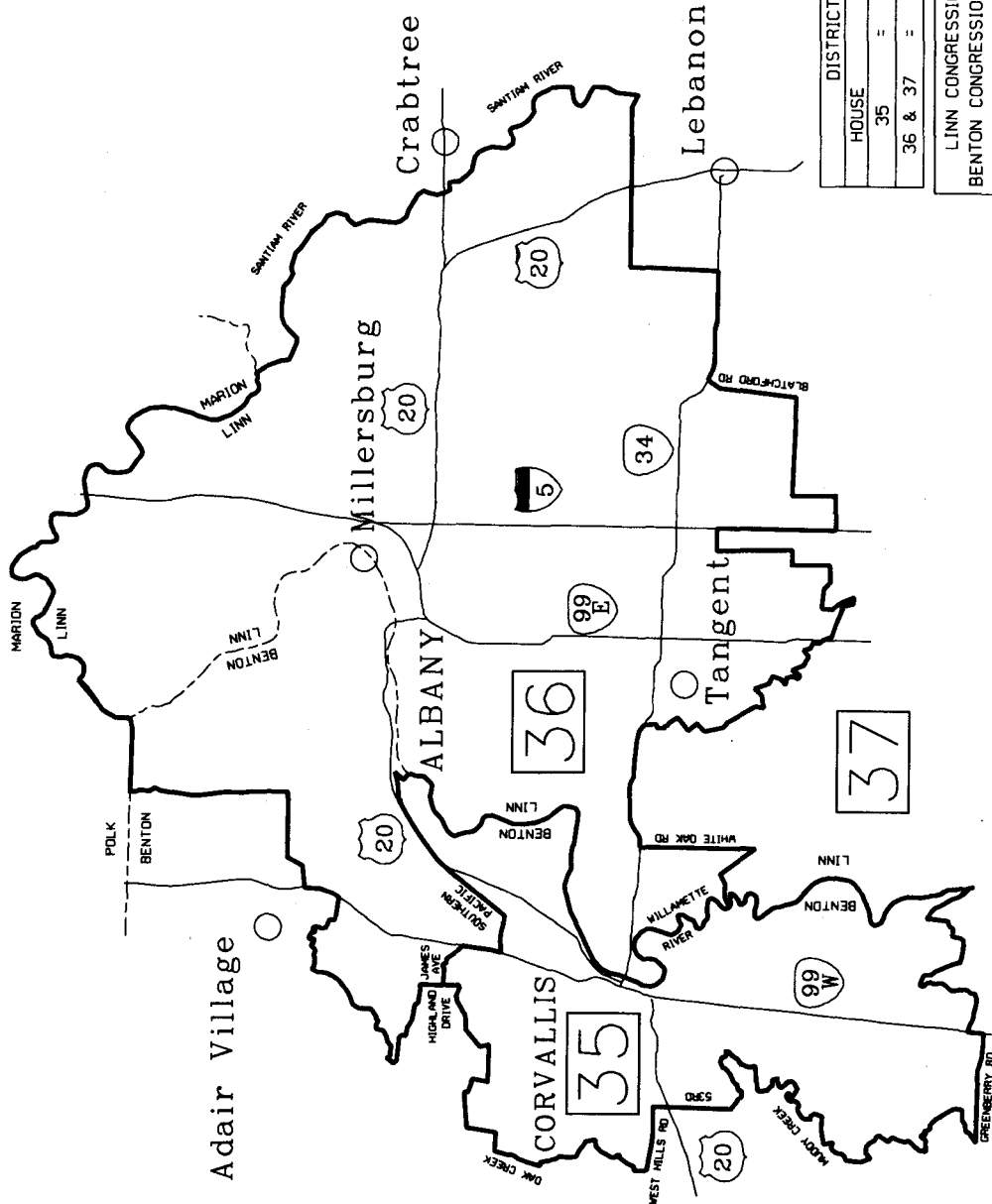

VOTING ACCESSIBILITY FOR ELDERLY AND INDIVIDUALS WITH PHYSICAL DISABILITIES

Pursuant to the federal "Voting Accessibility for the Elderly and Handicapped Act," Public Law 98-435, the State of Oregon has made the following provisions for voters who are elderly or who have physical disabilities:

1. A cassette edition of the Voters' Pamphlet is available for Oregonians who cannot read standard print due to a visual or physical disability. To order a cassette edition of the Voters' Pamphlet, please contact Vision Resources For Independent Living at 503-284-3339.

If you need information regarding where you vote, please call your county elections official. All other Voters' Pamphlet questions should be directed to the Office of the Secretary of State at 503-986-1518 or 503-378-5812 (hearing impaired).

2. Large-type voting instructions or hand-held magnifying glasses for the visually impaired will be provided at each polling place.
3. Telecommunications devices for the hearing impaired will be available in each county elections office. The special telephone number for your county is included in the list of county elections officials that appears on the "Absent Voter" information page in this pamphlet, or you may contact the Office of the Secretary of State by dialing 503-378-5812.
4. If an elderly or physically disabled voter's polling place is inaccessible, the voter may request, **in advance**, to have a ballot brought from the polling place to the voter's car, or to be assigned to an alternative polling place.
5. Any voter who is unable to mark or punch the ballot because of a physical disability or an inability to read or write shall receive, upon request, the assistance of two election board clerks of different parties or of some other person chosen by the voter. Under no circumstances may assistance be given by the voter's employer or an agent of the employer or by an officer or agent of the voter's union.
6. An absentee ballot may be requested by any elderly or physically disabled voter.

Details concerning the **nature of barriers** present at **polling places** designated as inaccessible may be obtained by contacting your county elections official.

ABSENT VOTER

You may apply for an absentee ballot from your county clerk if:

1. You are a registered voter; and
2. You have reason to believe you will be unable, for any reason, to vote at the polling place on election day.

Your application must be in writing and must include:

1. Your signature. (This is required, for comparison to your voter registration card.)
2. Your residence address.
3. The address to which the ballot should be mailed, if different from your residence address.

YOUR VOTED ABSENTEE BALLOT MUST BE RECEIVED IN THE OFFICE OF YOUR COUNTY CLERK NOT LATER THAN 8:00 P.M. THE DAY OF THE ELECTION, MAY 17, 1994.

If a registered voter is frail* or disabled, the application is valid for every subsequent election until the voter otherwise notifies the clerk or is no longer a voter in the county.

While you may apply for and receive an absentee ballot up to 8:00 p.m. on election day, if your application is received by the county clerk after May 12, 1994, the county clerk is not required to mail your ballot. If your ballot is not mailed, you must obtain it in person from the county clerk. Therefore, if you apply for an absentee ballot by mail, you must allow enough time to receive the ballot, vote, and return the ballot to the county clerk. **REMEMBER:** Your voted absentee ballot must be physically in the office of the county clerk by 8:00 p.m. on the day of the election, May 17, 1994, or it will not be counted.

* *Where walking as a means of transportation is impossible or impractical.*

LONG TERM ABSENT VOTER

You may apply for long term absent voter status with your county clerk or the Secretary of State if:

1. You are a resident of this state, absent from your place of residence; and
2. You are serving in the armed forces or merchant marine of the United States; or
3. You are temporarily living outside the territorial limits of the United States and the District of Columbia; or
4. You are a spouse or dependent of a long term absent voter. A spouse or dependent of a long term absent voter, not previously a resident of this state who intends to reside in this state, is considered a resident for voting purposes and may vote in the same manner as a long term absent voter.

Your application must be in writing and must include:

1. Your name and current mailing address.
2. A statement that you are a citizen of the United States.
3. A statement that you will be 18 or older on the day of the election.
4. A statement that your home residence has been in this state for more than 20 days preceding the election, and giving the address of your last home residence.
5. A statement of the facts that qualify you as a long term absent voter.
6. A statement that you are not requesting a ballot from any other state and are not voting in any other manner than by absentee ballot.
7. A designation of your political affiliation if you wish to vote in a general election.

The U.S. Department of Defense provides standard form 76 that complies with these requirements. It is recommended that

long term absent voters use this form—available at embassies and military installations—whenever possible.

Special absentee voting instructions and a ballot return envelope will accompany each absentee ballot.

Special Absentee Ballots: Any long term absentee voter may obtain a special absentee ballot for a primary or general election if the voter believes that:

1. The voter will be residing, stationed or working outside the territorial limits of the United States and the District of Columbia; and
2. The voter will not be able to receive, vote and return a regular absentee ballot by normal mail delivery within the period provided for absentee voting.

If you feel you may need a special absentee ballot, you should contact your county election officer for details.

REMEMBER, YOUR ABSENTEE BALLOT MUST BE RECEIVED BY YOUR COUNTY CLERK NO LATER THAN 8:00 P.M. THE DAY OF THE ELECTION, MAY 17, 1994.

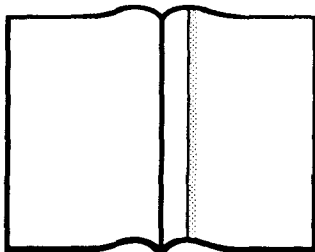
