


BENTON COUNTY, OREGON SAMPLE BALLOT March 28, 1995 District Election

MEASURE NO. 02-08 ALSEA DISTRICT NO. 7-J

Ballot Title:

02-08

ALSEA SCHOOL DISTRICT NO. 7J GENERAL OBLIGATION BOND AUTHORIZATION

QUESTION:

Shall the District be authorized to contract general obligation bonded indebtedness in an amount not to exceed \$2,915,000? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of section 11b, Article XI of the Oregon Constitution.

STATEMENT:

This measure, if approved, would authorize the District to issue general obligation bonds in a principal amount not to exceed \$2,915,000 Bond proceeds would be used to construct and equip a new gymnasium, lockers, media center, special education and science areas and support and office spaces to construct, remodel, equip and upgrade classrooms, gymnasium, music/stage areas and kitchen and storage areas; to make parking improvements and do sitework, and to pay all costs incidental thereto. The bonds would mature in not more than 26 years.

ARGUMENT IN FAVOR:

WHY THE SCHOOL BOARD IS PROPOSING THIS PROJECT

The school board is aware of many deficiencies in the present building. With this bond issue the school board hopes to correct them. Among the conditions that need to be corrected are the following:

- some teachers are using carts as desks and homerooms
- some areas of the school overheat, others require students to wear coats
- some basketball players start practices at 6:30 a.m. and others don't get home from practice until 10:00 p.m.
- anyone confined to a wheelchair can't use the restrooms or the library
- classrooms don't have enough electrical outlets
- attendance at basketball games sometimes exceeds the rated capacity
- lack of ventilation and storage for chemicals are hazards in the science room
- not enough room for books, equipment and computers in the library
- · half the kitchen is classroom space
- · staff has no way of knowing who is entering the building
- · poor acoustics for school productions
- no outdoor access to restrooms
- one modular classroom is inadequate for large classes, the other must be replaced

The bond issue covers the cost of providing:

- a new gym
- · a new library
- · a new science room
- new offices
- replacing wornout and inadequate electrical, heating and plumbing systems to meet state standards
- additional parking
- · general remodeling inside the school
- · provide for handicap access

Alsea School District has had no major construction for over 40 years. The building now is in need of remodeling and new construction. The proposed plan will have a maximum cost of \$2,915,000. This will result in an estimated average tax rate of less than \$3 per \$1,000 of assessed value for patrons.

ONE YEAR LEVY FOR MONROE UNION HIGH SCHOOL EMERGENCY REPAIRS

QUESTION:

Shall Monroe Union High School levy \$44,000 for emergency repairs to the high school old gym and science room?

SUMMARY:

The south-east wall of the old gym and science room are separating from the rest of the building and present a safety risk to the students. The cost of repair is \$44,000 or 38.62 cents per thousand assessed value. This is a one year only levy.

ARGUMENT IN FAVOR:

This levy would be used to repair the old gym and science room. The masonry wall is pulling away from and tipping out from the wood frame wall at the stage, resulting in a large crack from floor to ceiling. This condition has been under careful watch for years, and continues to decline. The engineering firm who has inspected the structure believes "that if we have any sort of major tremor nearby, such as the earthquake in Molalla or Klamalth Falls, the wall will collapse." It is obvious this condition poses a major safety risk to our students. The cost of repair is \$44,000 or 38.62 CENTS per thousand assessed value. This is a one year only levy.



You're reading this because you care about education, which means we have something in common. For the last two years, I have been working in Corvallis and Salem to promote stable funding and quality education.

Changes in property tax and equalization laws have stripped our district to a bare bones budget, while the school reform law demands too rapid a change. In the last 5 years, we have cut 88 teachers and 30% of administration, while enrollment continues to grow. Our whole system is strained by doing too much with too little.

We must rebuild credibility and a positive spirit in our district with these goals:

- Slow down educational reform. Do what we can afford with our top budget priority being classroom instruction. Before changes are made, be sure evaluation tools are in place to check student progress.
- Improve communication, especially with parents. They deserve direct and complete information about what is happening to their children's education and why.
- Create a community education coalition. Bring education. local government, business, human resources and parents together at one table. With cooperative planning, we can pursue local funding opportunities which will add resources to our schools.

You can count on me to work for these goals and to seek out your concerns. Our children are only children once.






