Justification of Her Course in Office by Cheryl McMorris, Mayor of Philomath

FACTS:

* The Mayor takes an oath to uphold the laws of the City and the State of Oregon.

* Protecting rights of property owners takes priority over following the wishes of a small group.

* Clearly this referendum referred only to annexations. No annexations have been done since 1994.

The Council relied upon the advice of the city attorney in continuing to allow delayed annexation agreements until the second CVA initiative passed. The legality of these is not in question.

My duties are mandated by City Charter and ordinances: preserve order, conduct city business, limit time a person may speak so meetings may proceed in an orderly and timely manner. A speaker is required to state their name and residential address. If a speaker will not comply then the speaker will be asked to sit down or leave.

The council meeting is open for the public to attend, but there is no absolute right for anyone but Councilors to speak. Participation is limited to those who are permitted by the Mayor.

A public hearing is different. Testimony is accepted, but the Mayor is expected to have the hearing proceed in a timely manner and limit repetition from the speaker.
