What to submit in person no later than 5:00 PM PST on filing deadline

- 1.A completed and signed BC405 Measure Argument for Benton County Voters' Pamphlet. The person(s) furnishing the argument must sign BC405.
- 2. Type written measure argument in Tahoma font type, size 12.
- 3. If measure argument has endorsements, submit completed and signed BC400 Statements of Endorsement.
- 4. Filing fee. If paying by check, make it payable to Benton County.

Electronic submission

E-Mail a Microsoft Word electronic text of the measure to <u>elections@bentoncountyor.gov</u>. The electronic text must be the same as the print version. If they are different, the filed hard copy version will take precedence.

Submitting an amendment in person or e-mail no later than 5:00 PM PST on filing deadline

- 1.A completed and signed BC405 Measure Argument for Benton County Voters' Pamphlet with the amended box marked.
- 2. Amended measure argument.
- 3. Removal, additional and/or amended completed and signed BC400 Statements of Endorsement.
- 4. No additional fee.

Measure Argument Requirements

- 1. Statement consists of words and numbers only.
- 2. One space after a period or punctuation mark.
- 3. One line space between paragraphs.
- 4. Charts and graphics are not acceptable.
- 5. The maximum word count is 325 words/numbers. The phrase "This information furnished by name and/or organization" which appears at the bottom of the column is part of the word count. If the word count exceeds the limit, it will be edited.
- 6. If a word is hyphenated and is listed in a dictionary as one word, it will count as one word. All other hyphenated words will count as more than one word.
- 7. Elections Office will reject arguments that contains any obscene, profane, scandalous, or defamatory language; incites promotes or advocates hatred, abuse, violence or hostility toward or which tends to cast ridicule or shame upon any person or group by reason of race, color, religion or manner of worship; or contains language which may not legally be circulated in the mail.
- 8. Elections Office will not correct errors in spelling, punctuation, grammar, or syntax.

Statement of Endorsement

- 1. See BC400 Statement of Endorsement for instructions.
- 2. Persons or organizations endorsing the measure argument submit BC400 Statement of Endorsement to the person submitting the measure argument, not to the Elections Office. All Statements of Endorsement must be submitted at the time the measure argument is filed.
