

Recording Fees

All fees shall be paid at the time of recording. Documents submitted for recording must be on letter or legal size white paper and shall meet all statutory requirements.

In some cases, documents submitted with deficiencies in certain recording requirements, may be accepted with the assessment of a \$20 Non-Standard fee.

Qualified multi-instrument documents will be assessed an additional \$5 per transaction title listed on 1st page.
